

LOCATION

Situated on Bradford Street in Digbeth, Bradford Court is only 3/4 mile from the City Centre, just minutes away from the Bull Ring Shopping Centre and Selfridges. Digbeth Coach Station and Moor Street Railway Station are also just a short walk away.
